My crew was 16-20 strong. Manage the grounds for a 5-Diamond Oceanfront Resort. My duties include keeping the landscapes, flowers, over 400 containers, and beach front up to 5 Diamond standards on a daily basis. Each visitor deserves to see us at our best. My challenges are learning what plants work with the salt air, and of course, the weather. We were impacted by tropical storms 2 years in a row.

### ***Landscape Operations Manager***

***Mar. 2015 – Aug. 2016 Jekyll Island Authority, GA***

Manage a crew of 25 to maintain the Jekyll Island landscape, including the historic district which includes historical plantings, a beachside park and adjacent convention center, a retail center, welcome center and causeway, 97 acres of turf and landscape beds in all. Also included is managing a colorscape division that involves 5 hot houses. We've made the tourists experience more enjoyable by adding more color to the landscapes, and have given them better turf, both St. Augustine and Bermuda grass, to enjoy their time here on the island.
